

# Nassau Virtual Enrollment Expectations for 2025-2026

The following information serves to help parents understand the enrollment expectations for Nassau Virtual School (NVS). Nassau Virtual students are withdrawn from their zoned brick-and-mortar school and enrolled as a full-time student in Nassau Virtual, which offers online learning through My District Virtual School (MDVS), provided by the North East Florida Educational Consortium. Students are required to meet the following expectations to foster a successful online learning experience.

## **Academic Expectations:**

- Maintain appropriate pace and a grade of a C or higher in all courses. The pacing expectations are found on the NVS 2025-2026 school calendar and tied to attendance.
- Live lessons will be offered each week by English, Math (grades 6-8, Algebra I, and Geometry), and Science (grades 6-8, Biology, Earth/Space, and Environmental) teachers. Live lessons are MANDATORY. The live lesson schedule will be available during computer pick-up.
- Complete the required number of courses for each year, six courses.
- Complete a minimum of 24% in the first 28 days after activation, or the student will be dropped from the course
- Tutoring sessions will be available during open office times. Students must complete the guided notes prior to the tutoring session.
- Students must uphold Academic Integrity as outlined in the NVS Handbook.

# **Communication Expectations:**

- Students and parents will complete a welcome call/email during the first week of the course. Each teacher will explain communication practices for their course.
- Students must complete discussion-based assessments (DBAs) before the module exam. Each teacher will instruct students on the correct procedures to complete a DBA.

# **Attendance Expectations:**

- The state of Florida mandates attendance. Students are expected to work a minimum of 25 hours per week.
- Attendance will be monitored weekly, every Thursday. Attendance is based on completed assignments for the
  previous week. A student is considered absent and off-pace if no assignments are completed within a seven-day
  period.

## **Testing Expectations:**

- According to F.S. 1008.22, all state assessments are mandatory for public school students.
- Students must complete all progress monitoring (PM1, 2, and 3) in-person for both reading and math assessments based on district and state requirements. (Please refer to testing dates in the school calendar.)
- Civics, US History, Algebra 1, Geometry, and Biology EOC exams count as 30% of the overall grade for the course. Students are required to attend all end of course review sessions as well as the FAST ELA review.

Your signature indicates the student and parent understand and agree to the academic, communication, attendance, and testing expectations for enrollment in Nassau Virtual. If the student falls behind in any area, Nassau Virtual may require an academic conference to determine if virtual learning is the best academic plan for the student.
