² In accordance with section 1007.35(5), Florida Statutes, each public high school shall offer all students enrolled in grade 10 the opportunity to participate in the PSAT. In addition, each school must provide a written notification to parents/guardians that includes the opportunity to exempt their child from participating.

³ Florida Partnership covers the cost of grade 11 students taking the PSAT/NMSQT during the SAT School Day. A passing score in Evidence Based Reading and Writing (EBRW) and/or Math can serve as a concordant score for ELA (EBRW) and/or Algebra 1 (Math). **See Rule 6A-1.09422: Concordant and Comparative Scores (F.A.C.) and applicable Table** <http://www.fldoe.org/core/fileparse.php/5663/urllt/Rule6A109422Ann-FAQ.pdf>

³Grade 11 students can take the Standard SAT during the Spring SAT School Day. Grade 10/11 students taking the PSAT/NMSQT will generate baseline data to assist in guiding instruction.

* Seniors who need a concordant score to satisfy graduation requirements should sit for the non-reportable (NCR) exam which has a 50% extended time accommodation. This administration is scheduled for October 14, 2020 and March 5, 2021.

** FLP districts have a high incidence of socio-economically disadvantaged students. CBFP suggests coding all seniors who need a concordant score as fee-reduction eligible.

♦ As of June 12, 2020, per Governor DeSantis, additional funds are allocated for 2020-21 Seniors to take the

Standard Reportable SAT. Fee reduction waivers will still be applied, available funds are through the CARES Act.

Test Participation and Score Reports

SAT School Day- September 23, 2020:

Standard SAT: Grade 12 student (Senior status) in need of a **Standard Reportable SAT score**. This includes students (Grade 11) in 2019-2020 who were previously scheduled for the March-June 2020 Standard SAT that was cancelled due to COVID-19. ♦

♦ *Campus Assessment Coordinators have rosters of eligible students.*

SAT School Day - October 14, 2020:

SAT-NCR: Any Grade 12 student in need of a concordant or non-college reportable (NCR) score should be scheduled for the October 14, 2020 or March 3, 2021 SAT-NCR School Day.

PSAT 8/9: Grade 8 and 9 students will participate in this assessment to establish data to increase instructional strategies. Students will need to create an account in College Board to receive score reports and have access to building future goals. PSAT data is also used to create Khan Academy supplemental material

PSAT/NMSQT: Grade 10 and 11 students will participate in this assessment to generate baseline data for instructional strategies and learning targets. The PSAT/NMSQT can also serve as a math concordant score and support students seeking scholarships. Campus educators, counselors, and administration can access score reports to create differentiated and flexible learning groups.

SAT School Day – March 3, 2021:

Standard SAT: Grade 11 students may participate in the Standard SAT. This is an additional opportunity and demonstrates growth from the October 14 PSAT. This data also serves to support, remediate, and enrich students moving into the 2021-22 school year.

SAT-NCR: Any Grade 12 student in need of a concordant or non-college reportable score should be scheduled for March 3, 2021 SAT-NCR School Day. These scores can be used as concordant scores to complete graduation requirements but are unable to be used for college entrance.
