<u>Rules</u>

- All attendees must be willing to submit to alcohol testing.
- All students and their guest may be searched for weapons and illegal substances prior to entry of the Prom.
- All students and guests must be picked up NO LATER THAN 11:15 P.M.
- Students who violate any school rule or terms of this contract will face disciplinary action.

FBHS reserves the right to search any student/guest or vehicle if they are at any school event.
