Volunteer Opportunities - Ashley Taylor explained the importance of completing a volunteer application on the district website. Approval is required for anyone to attend school functions both on and off campus.

School Improvement/Title I - Presented by Melissa Johnson

Mrs. Johnson presented CES's End of Year data from the 2023-2024 school year noting that our ELA results were 1st and 2nd in the district. She also noted how proud she is of the students, teachers and staff for all of their hard work.

• EOY Data Results: ELA-

K: District: 87% CES: 85%
1strict: 78.5% CES: 91%

o 2nd: District:76.3% CES: 77%

• EOY Data Results: Math-

K: District: 76.8% CES: 70%
1st: District: 89.1 CES: 95%
2nd: District: 84.5 CES: 85%

- Mrs. Johnson discussed the goals for the 24/25 School Improvement plan-
 - Attendance goal: Our goal is to decrease the number of students not meeting the 90% attendance by 3%. In the 2023-2024 school year, 24.86% of students were chronically absent (more than 18 days in the year). This goal will be reached by frequent parent contact via phone calls, letters home and home visits by administration. This is to ensure parents understand the district attendance policy and to convey the importance of regular school attendance by students.
 - Our goal is to increase scores by 2 to 5 % in each grade level. This goal will be reached by adding more intensive, targeted instruction to the lowest quartile of students. In-school and after school tutoring is still in place, but due to scheduling and/or transportation issues not all of our students have been able to receive this additional intervention. To combat this, CES has implemented WIN (Warriors in Need) time every morning. This time is dedicated to additional small group instruction to help bridge learning gaps. In addition to our teachers providing this instruction, paraprofessionals are pushed into each classroom 2-3 times per week.
 - o <u>Final School Improvement Plan</u>: Mrs. Johnson is working on this and it will be completed by mid October. She will send it in an email for approval by the SAC Committee. Once received, she asks that members review, make suggestions, and/or approve the 24-25 SIP Plan.
- Open House and Parent Survey Results: There were 85 surveys completed during our Open House event. One major addition to the event this year was the distribution of 631 readiness bags to families. These bags included items that can be used to assist families with student engagement during ELA and math homework/activities at home. Examples of items are: counting cart, whisper phone, fidgets, number line, alphabet strips, etc.
 - o 90.7 % said they received valuable information about their student and the school
 - o 89.5% said it was informative and worthwhile
- Mrs. Johnson also noted that we will continue:
 - o Mentor/ Mentee Observations for new teachers. This allows new teachers to be able to observe their mentor teacher during instruction time. The school provides coverage for the mentee's classroom during these observations.
 - o Mega & Mini Monday Professional Development sessions that are attended by all instructional personnel.
 - o Leadership walkthroughs. These allow our leadership to see our teachers in action and pinpoint any areas that may need improvement.
