**BRING YOUR OWN DEVICE (BYOD) AGREEMENT**

**Purpose:**

Nassau County Schools allows a Bring Your Own Device program for students to bring wireless devices for use in the classroom due to medical circumstances. Students wishing to connect their wireless device to the Nassau County School District's network must follow the responsibilities stated in the Responsible Use Policy as well as the following guidelines.

**Device Types:**

For the purpose of this program, the word "device" means a privately owned wireless and/or portable electronic piece of equipment that includes laptops, netbooks, tablets/wearable technology, and smart phones capable of accessing the Internet.

**Guidelines:**

1. Any student who needs to use a personally owned electronic device within the Nassau County Schools network must read and sign this agreement along with a parent or guardian.
2. The student takes full responsibility for their device and must always keep it with them. The school is not responsible for the security of the device.
3. The student is responsible for the proper care of their personal device, including any costs of repair, replacement or any modifications needed to use the device at school. No district staff member will diagnose, repair, or work on a student's device.
4. Administration reserves the right to inspect a student's personal device if there is reason to believe, in the school personnel's sole discretion, that the student has violated Board policies, administrative procedures, and school rules or has engaged in other misconduct while using their personal device.
5. Violations of any Board policies, administrative procedures or school rules involving a student's personally owned device may result in the loss of use of the device in school and/or disciplinary action.
6. The student must comply with all teacher requests to minimize disruptions during instructional time.
7. Personal devices shall be charged prior to bringing it to school and shall be capable of running off its own battery while at school.
8. The student should only use their device to access relevant files, websites, and apps that contribute to the student's medical needs.
9. All users must sign onto the district's designated BYOD network to ensure students are accessing only filtered content. All Nassau County Schools networks are filtered for the safety of users in compliance with federal and state requirements.
10. The Nassau County School Board makes no guarantees or assurances pertaining to the accuracy of student's electronic device(s).
11. The Nassau County School Board makes no guarantees or assurances that the network will remain operable at all times. Further, the Nassau County School Board makes no guarantees or assurances that student's medical needs will be met through connection of an electronic device with the network. It is understood that from time to time the network may become inoperable due to routine maintenance, power failures, or other technical issues. In the absence of network operability, the student and parent(s) retain complete responsibility for ensuring that student's medical needs are met without the use of student's electronic device.
12. The parents and students hereby release and hold harmless the School Board of Nassau County, Florida, along with its employees, from any and all claims for damage, whether based upon property damage, injuries, illness, or death, arising from student's use or inability to use the School Board's or the school's electronic network(s).

As a student, I understand and will abide by the above agreement and the Nassau County Schools Network/ Responsible Use Policy. I further understand that any violation of the above may result in the loss of my network and/or device privileges as well as other disciplinary action.

As a parent/guardian, I have read and discussed the above agreement and guidelines with my child. We understand the responsibility my child has in the use of their personal device and agree to the conditions contained herein.
